JOB DESCRIPTION

# **General Summary/Objective**

Manage the operation and maintenance of the MSUD surface water treatment plant, including pumping stations and storage tanks. Ensure that the water quality meets or exceeds regulations. Ensure compliance with all federal state and local regulations. Supervise the staff of the water treatment plant.

#### **Essential Functions**

- Interview, hire, and ensure training of staff.
- Supervise staff, including creating a monthly schedule.
- Oversee the plant's operations, including treatment, distribution, and maintenance.
- Manage the plant's operating budget.
- Manage the purchasing and control inventory of parts, equipment, chemicals and supplies.
- Analyze data and prepare reports to evaluate the plant's efficiency.
- Ensure the accuracy of records of operations, maintenance, and testing results.
- Respond to inquiries regarding water taste and odor and take corrective action when needed.
- Develop plans for monitoring programs and prepare reports for local and state agencies.
- Respond to emergencies, such as power outages or equipment failures, and take appropriate action to maintain water supply.
- Ensure that all safety protocols are followed, including the use of personal protective equipment and safe handling of chemicals.
- Communicate with the public, vendors, contractors, engineers, and consultants to provide technical information, review related material, and maintain adequate drinking water standards.
- Conduct tours and facilitate public relations for various groups, including new employee orientation, school tours, and contractor tours as approved by senior management.

#### **Competencies**

- Ability to identify and inform the operator on duty and or management of potential hazards and follow appropriate emergency protocols.
- Knowledge of state and federal regulations related to water treatment.
- Ability to follow applicable regulations, codes, policies and procedures.
- Ability to complete appropriate documentation and maintain records.

- Ethical Conduct.

#### **Supervisory Responsibility**

Supervise the water treatment plant staff.



#### **Work Environment**

While performing the duties of this job, the employee is required to work indoors, and sometimes outdoors in all types of weather. The work environment can include loud noises, grease, oil, dirt, water, chemicals, and other related conditions. Work around loud pumps and machinery. Work in a laboratory.

#### **Physical Demands**

The physical demands described here represent those that an employee must meet to successfully perform the essential functions of this job.

While performing the duties of this job, the employee is regularly required to use hands and finger to handle, feel or operate objects, tools, or controls, and reach with hands and arms. While performing the duties of this job, the employee is regularly required to walk, stoop, crouch, twist, turn, kneel, and bend. Prolonged periods of sitting at a workstation. Prolonged periods of working on a computer. Periods of working in standing water. Ability to climb a flight of stairs 20 or more times a day. Must be able to lift to 60 pounds. Ability to handle a 2.5" fire hose with a psi of 125.

## **Position Type/Hours of Work**

This is a full-time position of 40 hours per week. Standard office hours for the Superintendent are M-F, 8 hours per day.

Bachelor of Science in Chemistry, Biology, or related field beneficial in the operation and management of a water treatment plant.

Extensive knowledge and a minimum of 5 years of experience in operating and maintaining a similar surface water treatment plant.
